RELEASE, WAIVER AND INDEMNITY AGREEMENT

In consideration of being permitted to participate on a team in the **PIG WRESTLING** event activities, **RELEASOR**, his/her parents, his/her legal representatives, heirs and assigns, hereby releases, waives and discharges **SPONSORS**, their officers, employees and workers, from all liability to the **RELEASOR**, his/her parents, his/her legal representative, heirs and assigns, for any and all loss or damage and any claim for damages resulting there from or on account of any injury to participants person or property, even injury resulting in death of the participant whether caused by the negligence of the **SPONSORS** or otherwise while **RELEASOR** is participating in the **PIG WRESTLING** event activities.

RELEASOR agrees to indemnify the **SPONSORS** from any loss, liability, damage or cost they may incur due to the presence of individual participant or minor participant in or upon the areas whether the **PIG WRESTLING** activities will take place, whether caused by the negligence of the **SPONSORS** or otherwise.

RELEASOR hereby assumes full responsibility for the risk of bodily injury, death or property damage due to the negligence of **SPONSORS** or otherwise while in or upon the areas where the **PIG WRESTLING** activities will take place and while participating in the **PIG WRESTLING** activities.

RELEASOR expressly agrees that this release, waiver and indemnity agreement is intended to be as a broad and inclusive as permitted by the laws of the State of Wyoming and that if any portion thereof is held invalid, it is agreed that the balance shall; notwithstanding, continue in full force and effect. **RELEASOR** expressly understands that the **PIG WRESTLING** activities involve an inherent risk of injury to oneself and to others. **SPONSORS** are not liable for any injuries to those who participate in the **PIG WRESTLING** activities.
